1. UNDER THE DIRECTION OF THE AERIE, THE BANQUET AND SOCIAL ROOM SHALL BE IN THE CHARGE OF THE BOARD OF TRUSTEES AND SHALL BE OPENED MONDAY THRU SUNDAY FROM 12:00 NOON UNTIL 2:00 A.M. OR AT THE DISCRETION OF THE BOARD OF TRUSTEES.
2. UNDER THE DIRECTION OF THE AERIE, THE BOARD OF TRUSTEES SHALL HAVE CONTROL OF THE SOCIAL ROOM AND SHALL MANAGE, DISCHARGE, AND HAVE CONTROL OF ALL VOLUNTEERS. A VOLUNTEER IS DEFINED HEREIN AS A PERSON WHO WORKS FOR THE BENEFIT OF THE CLUB; PAID, VOLUNTEER OR OTHERWISE.
3. MEMBERS AND GUESTS ONLY. A NON-MEMBER IS PERMITTED TO BE A GUEST THREE (3) TIMES ONLY IF ELIGIBLE TO BECOME A MEMBER. IT IS RECOMMENDED DURING VISIT THREE, THE GUEST APPLY FOR MEMBERSHIP TO THE CLUB.
4. ALCOHOLIC BEVERAGES WILL NOT BE SOLD TO NON MEMBERS. ALL ALCOHOLIC BEVERAGES CONSUMED ON PREMISES MUST BE PURCHASED ON THE PREMISES.
5. ANY VOLUNTEER UNDER THE DIRECTION OF THE TRUSTEES IS NOT REQUIRED TO TAKE INSTRUCTIONS FROM MEMBERS. COMPLAINTS REGARDING SUCH VOLUNTEER SHOULD BE ADDRESSED TO THE TRUSTEES.
6. THE SOCIAL ROOM SHALL REMAIN OPEN DURING THE REGULAR MEETING OF THE AERIE.
7. THE PRICE OF DRINKS MAY BE SET OR CHANGED AT ANY TIME BY THE BOARD OF TRUSTEES.
8. VOLUNTEERS ARE PROHIBITED FROM GAMBLING, DRINKING, OR DANCING WHILE ON DUTY.
9. VISITING EAGLES MAY PRESENT THEIR HOME DUES RECEIPT TO VISIT THE SOCIAL AND BANQUET FACILITIES. WHEN A MEMBER (AERIE / AUXILIARY OR OTHERWISE) BRINGS A GUEST (NON EAGLE MEMBER) OVER THE AGE OF 18 INTO THE CLUB, THE GUEST MUST BE SIGNED INTO THE GUESTBOOK. MEMBERS ARE RESPONSIBLE FOR THEIR GUEST'S CONDUCT. ANY GUEST IS REQUIRED TO LEAVE WHEN THEIR HOST LEAVES THE CLUB AND GROUNDS.
10. ANY MEMBER HAVING BEEN REFUSED SERVICE, ADMISSION TO THE CLUB, OR REQUESTED TO LEAVE THE CLUB WILL ACCEPT SUCH ACTION AS BEING IN THE BEST INTEREST OF THE CLUB AND SHOULD MAKE NO ISSUE OF THE MATTER WITH ANY MEMBER OF THE CLUB.
11. FORMER MEMBERS DROPPED FOR NON-PAYMENT OF DUES ARE INELIGIBLE TO HAVE SOCIAL ROOM AND / OR BANQUET FACILITY PRIVILEGES OR TO BE SINGED IN AS A GUEST.
12. THE PROPER MEANS FOR A MEMBER TO VOICE CONCERNS IS TO ADDRESS THE AERIE DURING THE BUSINESS SESSION OF A REGULARLY SCHEDULED MEETING.
13. PUBLICATION NOTICES, POSTERS DISPLAYED, OR SALES OF ARTICLES WITHIN OR AROUND THE BUILDING WILL NOT BE ALLOWED OTHER THAN FOR CLUB PURPOSES AND WITH PRIOR APPROVAL FROM THE TRUSTEES.
14. WHEN A MEMBER DESTROYS OR DAMAGES ANY PROPERTY OF THE HOME OR AERIE AND REFUSES TO PAY THE FULL VALUE THEREOF, THE MEMBER WILL HAVE CHARGES FILED AGAINST THE MEMBER BY THE BOARD OF TRUSTEES. NO ARTICLES BELONGING TO THE HOME OR AERIE SHALL BE TAKEN FROM THERE EXCEPT IN THE INTEREST OF THE AERIE AND ONLY WITH WRITTEN CONSENT OF THE MAJORITY OF THE BOARD OF TRUSTEES.
15. NO CHILDREN WILL BE PERMITTED TO REMAIN IN THE BANQUET OR SOCIAL ROOMS BEYOND THE HOUR OF 10:00 P.M., ON SATURDAYS CHILDREN HAVE TO BE OUT BY 8:00 P.M. CHILDREN UNDER THE AGE OF 14 MAY NOT PLAY POOL. PARENTS MUST KEEP THEIR CHILDREN UNDER CONTROL AT ALL TIMES.
16. IT SHALL BE THE DUTY OF THE TRUSTEES, THROUGH ORDERS TO THE MAINTENANCE MANAGER, TO KEEP ALL CLUB PROPERTY IN A CLEAN, ATTRACTIVE, AND SANITARY CONDITION. EVERY MEMBER IS ENJOINED TO HELP THE MAINTENANCE MANAGER TO KEEP THE HOME IN A NEAT AND ATTRACTIVE MANNER.
17. THE CLUB WILL ASSESS A FEE OF \$25.00 FOR ANY BOUNCED CHECK. THIS FEE IS IN ADDITION TO ANY BANK FEES LEVIED. REPEAT OFFENDERS COULD BE SUBJECT TO ADDITIONAL DISCIPLINE.
18. SERVICE DOGS ONLY WILL BE PERMITTED IN THE AERIE DURING BUSINESS HOURS (I.E. LEADER, HEARING, PHYSICAL AND EMOTIONAL NEEDS, ETC.).
19. SEXUAL HARASSMENT OF ANY KIND WILL NOT BE TOLERATED.
20. ANY VIOLATION OF THE HOUSE RULES, BY LAWS OR A VIOLATION IN ACCORDANCE WITH SECTION 63.2 OF THE CONSTITUTION WILL BE DEALT WITH BY THE BOARD OF TRUSTEES. VIOLATIONS ARE PUNISHABLE BY SUSPENSION OF SOCIAL ROOM PRIVILEGES OF UP TO NINETY (90) DAYS.
